Further to this MEDILOGIK LTD is committed to achieving a 50% reduction for emissions in Scopes 1,2 and 3.

4. Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease to 74 tCO₂e by 2030. This is a reduction of 50%.

As 2023 is a baseline report, MEDILOGIK are unable to provide a graph to demonstrate previous reductions, from 2024 MEDILOGIK’s Progress against these targets will be seen in a graph.

5. Carbon Reduction Projects

5.1.1 Completed Carbon Reduction Initiatives

Due to 2023 being MEDILOGIK’s baseline year, we have not yet completed any specific carbon reduction initiatives. However, since 2021 MEDILOGIK has been a completely remote business, and have wherever possible been reducing staff travelling to customer sites.

2024s Carbon Reduction Plan will show MEDILOGIK's progress.

In 2024 MEDILOGIK hope to implement measures such as:

- Encouraged use of public transport when visiting customer sites.
- Encouraging customers to utilise video support and training during procurements reducing travel emissions.
- Reducing our reliance on consultancy that increases our Scope 3 emissions.
- Reducing the use of external activities such as marketing firms or any other company that is not able to demonstrate their commitment to net zero.
- Working with our cloud hosting provider to identify measures to reduce our footprint on their infrastructure.
- Work closely with our customers to ensure that all postage costs for equipment are kept to a minimum to reduce postage emissions.
- Although not a reduction initiative, we shall investigate the options to provide customers opportunities for offsetting their carbon for any costs that cannot be reduced by MEDILOGIK.

6. Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.
